Higher Education Updates

House Bill 16--Student loan debt and the cost of college tuition are topics we see in the news a lot these days. Likewise, the difference between in-state and out-of-state tuition is highly scrutinized. In Ohio, the law currently prevents individuals who reside in Ohio primarily to attend institutions of higher learning from receiving in-state tuition; however, there are limited exceptions to that rule. One of the limited exceptions to the general rule is that all state institutions of higher education (defined by Ohio Revised Code 3345.011) must grant residency status for college tuition to active-duty service member, veterans, their spouse and dependent(s) if the eligible individual has established domicile in Ohio *as of the first day of a term of enrollment* in an institution of higher education. The General Assembly is legislating an expansion to that exception.

Introduced on February 12, 2019, House Bill 16 (H.B. 16) would extend residency rights to current and former service members, their spouse and dependent(s) by waiving the domicile deadline requirement if the student: (1) established he/she is an eligible active-duty service member, veteran, spouse or dependent, (2) has accepted full-time employment, and (3) established domicile in Ohio for reasons other than gaining the benefit of favorable tuition rates. H.B. 16 currently has 33 co-sponsors. On February 13, 2019, the bill went to the House Higher Education Committee for review.

COHEAO Update—

- 1) **Federal Perkins Loan Program**-With the expiration of the Federal Perkins Loan program, COHEAO is working to ensure an orderly wind down of the program that protects the Institutional Capital Contributions of institutions. COHEAO is also advocating to have the ACA tied to collections rather than disbursements in light of the program's sunset. COHEAO continues to promote a replacement for the program that will allow institutions to continue to fill gaps in funding that may otherwise result in students having to withdraw.
- 2) COHEAO Workshop—COHEAO is pleased to announce a one-day workshop on April 10, 2019 at the beautiful campus of Southern Methodist University in Dallas, TX. Topics will focus on affordability, payment options and funding trends and will delve into key topics that impact institutions. Sessions will cover Prior Term Loans, Developing and Managing Institutional Loans, Innovations in Tuition Payment Plans and Best Practices in Third-Party Collections. - 3) **COHEAO Webinar**—COHEAO will be featuring a webinar in March (date TBA) exploring the topic of "Bankruptcy in Higher Education", presented by Robert Schuerger of Schuerger Law Firm.
