The OBA board of trustees has worked diligently to foster strong working relationships between schools, business partners and the Ohio Attorney General's staff. Our organization is striving to increase membership of schools and business partners as this can only improve our understanding of improvements needed in Higher Education today. I invite all of you to consider playing a more active role with the OBA by joining the board of trustees. Not to mention the personal and professional growth that you can experience by becoming a member. We have a few openings for the upcoming year—including President-Elect, Secretary, Four-Year Public Representative and Four-Year Private Representative. Please consider one of these opportunities—your experience and knowledge would be greatly appreciated.

Kim Engle, President-Elect, has been busy planning the Spring Conference that will be held in Cincinnati on March 12th and 13th, 2020. Her conference will have a two-day format allowing schools and business partners to reduce their lodging expenses. The OBA will have a special "early-bird" price for attendance at the spring conference of \$195 per person. If registration takes place after the deadline, the price will be \$250 per person. Registration will open on January 2nd, 2020 at ohiobursars.org.

Our two-day fall conference for 2020 will take place in Columbus at The Grand Event Center, which was the location of the past Fall Conference. You won't want to miss this opportunity to hear the most up-to-date regulatory developments and network with your colleagues and business partners.

Based on key interest from the 2019 fall conference in reference to the current budget of the OBA, Jasmine Anderson, OBA Treasurer, has provided the following excerpt to assist with financial transparency between the Board of Trustees and its members:

The financial cycle for the Ohio Bursars Association begins in July with the invoicing of membership dues. Current membership amounts are \$200 for institutions and \$1,000 for business partners. As of to date, 48 institutions and 19 business partners have remitted payment of dues for the 2019-2020 fiscal year.

Dues are collected upfront to assist with funding the annual fall meeting, currently a 1-day event that is budgeted at \$10,000, and aid in planning for the 2-day spring conference, which is budgeted at \$30,000. For both events, the majority of expenses stem from food services, which can be 45-50% of the total conference cost.

As we transition our larger conference event from spring to fall, in 2020, the OBA will face back-to-back 2-day conferences, which, if the current budget trend stands, will cost \$50,000-\$60,000. Our current balance is \$58,095.42. Please refer to the 2019 Fall Newsletter Treasurer Report included below for more information.
