Summer 2023 Board Meeting

July 25, 2023

- I. The meeting was called to order at 10:04am by President, Becky Sparks.
- II. **Old Business:**
 - a. Membership Report – Scott
 - i. As of 7/20:
 1. Invoiced 60 schools; 40 paid.
 2. Invoiced 27 business partners; 14 paid.
 3. Continuing outreach for business partners.
 - b. Treasurer Report – Andrea
 - i. Andrea provided the 22-23 FY treasury report.
 - ii. Removed PO box from budget-not billed or paid for in 2 years.
 - iii. Cashnet – use for electronic checks as well and not just credit cards? Avoid needing to worry about checks being in mail. Find out how much Cashnet charges.
 - iv. Website hosting fees include fees for app, so cost is higher than in the past.
 - v. Need to make at least 1 transaction through bank account to avoid being charged \$50 inactivity fee. Find out if 5/3 offers different type of account that would avoid being hit with fee? Got hit with fee for 06/2023 due to no activity. If 5/3 can't accommodate – consider switching banks.
 - vi. A motion was made to approve the Treasurer Report by Shannon Hadding; a second to approve was made by Leigh Jackson. **The motion carried.**
 - c. Becky provided Spring 2023 Board meeting minutes.
 - i. A motion was made to approve the Spring 2023 Board Meeting minutes by Leigh Jackson; a second to approve was made by Andrea Seward. **The motion carried.**
 - d. July OBA Zoom call – about 30 participants, survey sent in advance so there were topics to discuss.
 - i. Fall Zoom call 11/15/23 – get talking points from members at the conference.
- III. Fall Conference 2023
 - a. Oct 17 – OBA Board Meeting
 - b. Oct 18 – OBA Conference

- c. Possible space: Nationwide Conference Center
 - i. What drives people to come to conference? Try a central location in Columbus
 - ii. Send poll to schools who didn't come or didn't send a lot of people to find out what kept them from attending. Cost? Place? Something else?
 - d. Speakers/Topics for FA23 conference
 - i. Invite AG
 - 1. Have more than 1 session during this time for private schools
 - ii. Business partners usually provide topics they want to present.
 - iii. Customer service type session
 - iv. Discuss holding transcripts
 - v. ListServ Live!
 - vi. 1098T
- IV. Spring 2024 Conference
- a. Offer option for just 1 or 2 days of conference instead of requiring all 3 days
 - b. Just 2 days for Spring
 - c. Start early to encourage additional attendance
 - i. No confirmed dates yet – looking at April again.
- V. Invoices
- a. Scott and Becky to invoice schools for 23/24 – use google docs? – send out first week of august – due date 30 days out from that date. Will need to pay before fall conference to attend.
 - b. Increase membership fees for schools
- VI. Updated Budget for 23-24 FY
- a. Andrea/Becky provided updated 23/24 Budget for the FY
 - b. Increase membership fee for schools to \$250 beginning the 23/24 FY
 - i. Hope is that 50 schools will pay
 - c. Business partners memberships still \$1000
 - i. Hope is that 20 will pay
 - d. \$250 for SP24 conference registration
 - i. Hope is that 75 will pay/attend
- VII. **New Business:**
- a. Introduce new Business Partner Board Member – Nick Heldman
 - b. Ideas for increasing member engagement
 - c. OBA website
 - i. New website coming (issues with the current one) Virgil – had to get new domain – once we get conference planned and details, then get website more 'user friendly'.
 - 1. Had issues on the backend with previous domain
 - a. Current URL is a 'dead' link
 - 2. New domain: www.ohiobursarsassociation.org
 - 3. New modern look and feel
 - 4. Upgrade security flaws that were in previous website
 - 5. Delaying app launch since website and app will 'talk'
 - 6. Multiple board members will get access to website to avoid issues with transferring access in the future

7. Can setup email addresses (ex: treasurer@ohiobursarsassociation.org).
Can be transferred to new board members as they come into OBA.
 8. Virgil to verify new website design isn't an extra cost from yearly charge

 - i. Scott said 14 more are coming back – maybe 6 more
 - ii. Business partners want to know how they can help schools reduce their workload
